STANDING RULES

ANTELOPE HILLS WOMEN'S GOLF ASSOCIATION

(Standing Rules updated and approved April 2025)

- 1. Annual dues will be \$75 (\$40 AHWGA Dues, \$35 AGA mandatory dues, if paid during the early registration period October 1 December 31. After December 31 the AGA dues are \$45). NAWGA membership is an optional fee of \$10. Dues will not be prorated during the year. A late fee of \$10 will apply to all members renewing after December 31, unless modified by the Executive Board.
- 2. New members that join online October 1 December 31 may sign up for weekly play but will not be part of the weekly game until their membership becomes active January 1. They may participate in the Closest to the Pin.
- 3. The Treasurer will pay team registration when requested by the Team Play Captain. The team is responsible for any expenses (shirt, gas, etc.) that they incur.
- 4. Any Hole-in-One will be recognized only if it occurs during official league play and qualifies for the Hole-in-One fund provided the player has contributed to the fund. It must be witnessed by at least one other person.
- 5. Breaking 100, 90, 80, 70, eagles, birdies and chip-ins are official when validated by scorer and attested on any LEAGUE play day, regardless of the number of players i.e. whether or not Weekly Play money is paid out for that day. All putts must have been holed out (no "gimmies") and no adjustments made to the hole score. No "mulligans".
- 6. Members must sign up by 11:00pm Monday to play Thursday of that week. Please call Monthly Volunteer(s) prior to Thursday if you cannot play. The phone numbers have been sent to each member. If you must cancel Thursday morning, call the Monthly Volunteer(s) on their cell phones: otherwise call the Pro Shop at 928-776-7888.
- 7. The Weekly Sweeps Chair or her proxy will use Tuesday's handicaps for league play on Thursday's.
- 8. The Club Championship is a gross tournament. The Eclectic is a net tournament. If played, the President's Cup is a Match Play Tournament with handicaps.
- 9. Minimum for weekly play is twelve (12) players starting.
- 10. Any individual person will be allowed to play as a guest with the Association a maximum of 5 times per year. A guest may participate in the Closest-to-the-Pin event, but not the Play of the Day.
- 11. The Antelope Hills Women's Golf Association will schedule no Interclub or Intraclub tournaments that compete or conflict with any NAWGA or AGA tournaments.

- 12. Regulation play is in effect unless otherwise posted. The Handicap/Rules Committee, in consultation with the Golf Shop will make the determination of the start of "preferred lies/winter rules" and the definition of how "preferred lies/winter rules" will be used.
- 13. If a hole is no part of the "Play of the Day", a member may pick up, taking the most likely score or net double bogey whichever is the lesser score and mark an X on the scorecard. The member is ineligible for low gross or low net that week.
- 14. Local Rules are posted on the AHWGA website, in the locker room, and provided to each member.
- 15. Distance Measuring Devices: You may obtain distance information by using a device that measures distance only for any AHWGA competition.
- 16. Most Improved Player Award: To be eligible for this award, a member must participate in twenty AHWGA league games within the year. The Award will be determined by your posted scores using the handicap calculation to compute an ending handicap that reflects only league play. AHWGA will be responsible for providing the award.
- 17. The Weekly Sweeps Chair is the final determiner of weekly pairings.
- 18. If the AHWGA board determines that a member has breached the Code of Conduct, the following actions will be taken:
 - First Offense A written warning outlining the specific infraction will be sent to the
 offending member with a copy of the Code of Conduct and reference to the Standing
 Rule that outlines disciplinary action.
 - Second Offense The member will receive written notice outlining the specific infraction and will be notified of a consecutive 4 week suspension from all AHWGA affiliated activities.
 - Third Offense The member will have their membership revoked and they will forfeit their membership fees. Consideration of future reinstatement of membership will be at the discretion of the AHWGA Board of Directors.
