CLGA GENERAL MEMBERSHIP MEETING

PRIOR MEETING MINUTES: Sandy Eeds moved to approve minutes from last meeting. Denise Orthen seconded. Motion passed.

SPECIAL GUEST: Dir. Of Golf Course Maintenance, Scott Anderson, was ill and could not attend.

RULES: Terry Gaube announced that revised scorecard management procedures were on the website. She encouraged everybody to read the explanation of Golf Genius. Captain's duties are also posted on the website. The player's name at the top of the Score Card is designated Captain. Her job is to ensure that the hole by hole score count is correct. If there are disputes, those holes should be circled and brought to the attention of the Pro Shop. If two or more players contest someone's score, it won't be certified until decided by Rules Chair.

CLGA WEBSITE. Zara reminded us there is good information on the website and encouraged us to refer to it often.

LUNCHEONS: If you need to cancel before a luncheon, call the Treasurer (Paddy Newton or Pat McRoberts) and Pro Shop before noon on Wednesday. Treasurer will notify event chair of changes.

GOLF GENIUS (GG). Nancy Hermanson discussed with the pro shop their need to notify us before initiating new procedures such as GG. Jon Griglak will try to remember to do so. If you receive an email from Jon regarding signing up for CLGA, sign up that way. If there is no GG code on scorecard, you will not use GG for scoring that day. For example, GG was not used for match play. Match play scores will not be posted, according to the pro shop. Refer to the website for GG tutorial.

PARTNERS TOURNAMENT: Rachel Rainville said the dates for this tournament are February 1 and 8. Luncheon will follow play on Feb. 8 Sign up on website. A list will be posted in the pro shop bathroom for those needing a partner... if you do not have a partner, we will get you one. January 25 is the cutoff for luncheon checks. No exceptions. Explanation of play in the partners tournament is posted on the website. Golf genius will be used. If you cannot play in the partners tournament but want to play one of the days, sign up on Chelsea and then call the Pro Shop before Wednesday NOON to say you will not be playing in partners event. Only 10 stroke differences will be allowed ... a larger gap between partners will forfeit strokes.
