

STANDING RULES

KEN MCDONALD WOMEN'S GOLF ASSOCIATION

TEE TIMES: Tee times may be obtained online for yourself and up to three other members beginning one week in advance of play.

SCORE CARDS: Members are responsible for accurate scoring and, unless otherwise noted, for posting scores to USGA within the required timeframe. Two scorecards must be kept. Incorrect scores will be rejected for POD/tournaments. All score cards must be signed and attested.

MEMBERSHIP: A woman may apply for membership through the Membership Chairperson. To become a member each applicant must have an established USGA handicap or submit 3 completed 18-hole score cards from USGA rated courses to the Handicap Chairperson.

Membership shall be limited to 125. If the board feels that circumstances warrant an increase in membership, they may do so at any time during the season. However, the Pro Shop must approve additional tee times.

In order to maintain your membership, you must play a minimum of five (5) league play days during the season. Membership includes chip-ins, birdies, hole-in-ones, and booklet. For those players joining after the regular season begins the number of rounds required to maintain membership shall be pro-rated by the Membership Committee. If you are unable to complete all of the required rounds, please contact the Membership Chairperson for determination of continued eligibility.

TOURNAMENTS: The Entrants for the major tournaments (President's Cup, Partner Best Ball and Club Championship) will have tee times assigned according to the guidelines of those tournaments. Sign-up sheets for tournaments will be available at least two weeks prior to play. The Tournament Director will post the rules.

Active members in good standing who have paid their dues and have an established handicap will be eligible to play in the first tournament of the year.

A member must have played on five (5) league play days to play in the Club Championship and President's Cup. However, a late season member is eligible for the President's Cup if they have played in at least 50% of league rounds from the time they joined up to the first day of the tournament; but they must have played in no less than 2 league rounds. A written request for exemption to this rule may be forwarded to the Board with an appropriate amount of time for Board consideration.

Tournament Day cancellations due to weather will be declared only after a Ken McDonald staff member and the Tournament Director determine the course is

unplayable. Tournament participants need to be present and ready to play. Weather cancellations will be considered at the time of the first scheduled tee time.

BIRDIES, CHIP-INS, AND HOLE -IN-ONES: Cash awards will be handed out at the final Awards Mixer at the end of the season. Cash awards will be available until the next season opener. If Members cannot attend the Awards Mixer, they should contact the Treasurer to make arrangements to pick up their cash payout, prior to the next season Opening Mixer. If the Treasurer is not contacted by the next season Opening Mixer, regarding the payout, the money will go back into the league treasury.

AMENDMENTS: These Standing Rules may be amended by a 51% vote of the Membership either by vote at any general membership meeting, online or by email provided written notice of same shall have been presented at a general membership meeting and/or posted on the bulletin board or emailed at least thirty (30) days in advance of vote.

These Standing Rules provide additional details to the By-Laws and shall not override the By-Laws.

The Member Handbook contains detailed information on the current year's procedures.
